Further to your request; please find below our explanations and comments regarding "Barış için Kadın Sesi" project, commenced by "Ses Eşitlik ve Dayanışma Derneği" (Association), carrying out its activities according to provisions of "Associations Law numbered 5253", in 01.01.2022-31.12.2022 period.

## I. Introduction

This report is issued for the reporting of studies and results performed in the framework of article 7/G-f of "Regulation on Principles and Procedures Regarding Documents to be certified by CPAs, Certification Subjects and Certification" published with respect to authorization granted by Law numbered 3568 and Serial No. 3 General Communique on Certified Public Accountant and Sworn-in Certified Public Accountant Law in order to determine whether "Barış için Kadın Sesi" project, commenced by "Ses Eşitlik ve Dayanışma Derneği" (Association), carrying out its activities according to provisions of "Associations Law numbered 5253", in 01.01.2022-31.12.2022 period is executed in the framework of principles and procedures in scope of related Law and details of respective expenses.





## II. INFORMATION ON "BARIŞ İÇİN KADIN SES'İ" PROJECT

The "Barış İçin Kadın Ses'i" project, implemented by the SES Eşitlik ve Dayanışma Derneği in collaboration with Operation 1325 and the Swedish Institute, aims to address the issue of "peace" and "security" from the perspective of women and to act as an intermediary in raising the voice of peace in civil society and the media.

The project also draws attention to the Security Council Resolution numbered 1325, in other words, the effects of armed conflicts on women and girls, the role of women in maintaining peace, and the gender dimensions of peace and conflict resolution processes.

Details of the project team are given below.

The association organizes podcasts within the scope of the Barış için Kadın Sesi project, which is carried out with the support of Operation 1325 and the Swedish Institute. Podcasts consist of three podcast series titled "Sanatta Kadın SES'i", "Sivil Toplumda Kadın SES'i" discussing the role of civil society in peacebuilding, and "Global SES" that discusses peace and international relations in Turkey from a gender perspective.

In addition, the Association produced 5 video-documents within the scope of its activity within the scope of the project.





## III. EXPENDITURES MADE IN SCOPE OF "BARIŞ İÇİN KADIN SES'İ" PROJECT

The total expenditures of the association within the scope of the "Barış İçin Kadın SES'i" project for the period 01.01.2022-31.12.2022 is 543.571,22 TL and the details are as follows:

The association records the project expenses that it has started in the current period for its purpose, but has not yet concluded, at the end of the year in the "280 Long-term Prepaid Expenses" account. In this context, the association transferred the project expenses from the "770 General Administrative Expenses" account to the "280 Long-term Prepaid Expenses" account.



As of the date of the report, the total expenditures of the association in 2023 within the scope of the "Barış için Kadın Sesi Project" is 92.741,78 TL. The content of the said expenditures consists of the wage payments of the individuals involved in the project, the audit and social media expenses.

The total expenditures of the association within the scope of the "Barış İçin Kadın SES'i" project for the period 2022 and 2023 is 636.313,00 TL.( Total expenses according to the trial balance are TL 606.315,79. The difference amount of 30 thousand TL results from the audit invoice that will be issued and booked in March.)
